Bachelor's Degree in Computer Science, a Master's in Public Administration and a PhD in Public Policy; all completed in the United States of America.


### Ms Maura Barry Boyle

for Asia (RDMA) in Bangkok, Thailand. At RDMA, Ms. Barry also served as a Regional Advisor for Local Capacity Development. Her assignments have also included serving in Afghanistan as the Deputy Office Director for USAID's Office of Democracy and Governance from 2011 - 2012. Before that, Maura served as USAID East Africa's Office Director for the Somalia. She holds an MPA in Public and Non-profit Management from New York University.

## **Dr Douglas Slater**



Dr Douglas Slater is the Assistant Secretary-General, Human and Social Development, CARICOM Secretariat.

Dr Slater assumed the position on 1 October 2013. A national of St. Vincent and the Grenadines and a Medical Doctor by profession, Dr. Slater was the Minister of Foreign Affairs, Foreign Trade and Consumer

Affairs of St. Vincent and the Grenadines from 2010-2013. In that capacity, he also served as representative of St. Vincent and the Grenadines to the ACP-EU Parliamentarians Group, and as alternate for the Prime Minister and Minister of Finance on the Caribbean Development Bank (CDB) and Eastern Caribbean Central Bank (ECCB) Authorities.

Slater served as Minister of Health Dr and the Environment, St. Vincent and the Grenadines, and was the CARICOM Minister of Health designated to negotiate the regional approach with the Global Fund to fight AIDS, TB and Malaria (GFATM) during the establishment of the GF. He also served as Chairman of the Organisation of Eastern (OECS)/Regional Coordination Caribbean States Mechanism (RCM). Dr. Slater was also honoured by the Caribbean Community (CARICOM) Secretariat as one of the CARICOM's first Champion for Change.

### Hon. Dr Timothy Sylvester Harris, Prime Minister of St Kitts and Nevis and Lead Head for Human Resource, Health and HIV



Hon. Dr Timothy Sylvester Harris is the current Prime Minister of St Kitts and Nevis. He previously served as the Foreign Minister from 10 August 2001 to 25 January 2013.

He graduated from the Cave Hill Campus of The University of the West Indies with a B.Sc. Degree with a First Class Honours in Accounting being the only

graduate of the B.Sc. Accounting programme to obtain this distinction.

Minister Harris holds a Doctor of Philosophy Degree in Administration majoring in Accounting. He participated in elective politics in 1993 and since then won his seat on a St. Kitts-Nevis Labour Party ticket, in each parliamentary elections held in 1995, 2000, 2004, and 2010. Dr Harris has served as Minister of Agriculture, Lands and Housing, Minister of Education, Labour and Social Security, Minister of Foreign Affairs and Education and Minister of Foreign Affairs, International Trade, Industry and Commerce.

He has published several works and received several award including the St Kitts Youth Council Award for Excellence in Education, the FESTAB Community Award for outstanding contribution to FESTAB and a certificate for outstanding contribution to the Cayon High School.

## Hon. Delroy Chuck, Minister of Justice, Jamaica



The Hon. Delrov Chuck was first elected in 1997 as a Member of Parliament (MP) to the represent Constituency of North East St. Andrew. In when 2011. the Jamaica Labour Party (JLP) won the

General Elections, he enjoyed a short stint in office as the Minister of Justice. In February 2016, Mr. Chuck was once again assigned to the portfolio with the mammoth responsibility of '*providing a law-abiding society with an accessible, efficient and fair system of justice for all*'.

He has worked steadily at various levels of the political and governance systems. He served as Research Director, Committee on Capital Punishment, Jamaica, 1979; the Chairman, Penal Reform Committee, Barbados, 1980; University nominee, Committee on Constitutional Reform; Opposition Spokesman on Justice 1997 – 2007; Speaker of the House of Representatives 2007 – 2011.

Minister Chuck also served as a Teacher in Mathematics. Senior Lecturer in Law, columnist for the Gleaner and commentator social. political. newspaper. on constitutional and legal issues. economical. He was consultant on the Judicial System and Legal Aid in Jamaica, the author of many published papers on law and crime including 'Should We Hang' and 'Understanding Crime'.

A graduate of Kingston College where he served as Deputy Head Boy, he won a scholarship to the University of the West Indies (UWI), Mona Campus, where he read for and received an Honours Degree in Special Mathematics.

His hard work and keen attention to detail paid off when he became the Jamaica Rhodes Scholar in 1973. He went on to St. Catherine's College at the University of Oxford, England, where he read Law.

### **Dr John Edward Greene**

Secretarycurrently UN General Special Envoy for HIV Caribbean in the and Professor Emeritus, UWI was previously the Assistant Secretary-General, CARICOM Secretariat and Senior Adviser. PAHO/WHO. At UWI. he was Vice Pro Chancellor and University Director, Institute of Social and Economic Studies.

He has authored 10 books and over 60 articles, served on many prestigious Boards and is the recipient of numerous awards. He holds a B.Sc. Economics (London University) and Ph.D. (University of British Columbia). Dr. Greene is a 2016 Caribbean American Heritage Awards (CARAH) honoree for Outstanding Public Service.

Ambassador Manorma Soeknandan, PhD, is the Deputy Secretary-General of the CARICOM Secretariat.

Before joining the CARICOM Secretariat Ambassador Soeknandan served as the first female Resident Ambassador of the Republic of Suriname to Guyana. She was also the first female Ambassador in Guyana. In January 2002, she was accredited as Ambassador to CARICOM.
