About IPPF

The [International Planned Parenthood Federation \(IPPF\)](#) is a global federation of 131 member associations, united by a common goal: that all human beings, especially women, girls and young people have access to sexual and reproductive health and rights (SRHR), in a world where human rights and gender equality are a reality. The International Conference on Population and Development (ICPD) Programme of Action continues to guide the work of IPPF Member Associations around the world to serve every woman, a girl or a young person and support their sexual and reproductive freedom.

Created in 1952, IPPF is locally owned and globally connected. We work in 161 countries in Africa, Asia, Europe, Oceania, the Arab World, and the Americas and the Caribbean. In 2019, we provided more than [250 million sexual and reproductive health services](#) worldwide, 81% of them to people living in poverty.

The IPPF Secretariat is comprised of five regional offices in Kuala Lumpur, Tunis, Brussels, Delhi, Nairobi, three intergovernmental advocacy liaison offices in Ethiopia for the African Union and in Geneva and New York for the UN. IPPF has a central office in London.

IPPF strongly believe in global solidarity and the universality of sexual and reproductive rights and gender equality. We are committed to strengthening dialogue and consensus, mitigating fragmentation at a time when our cause needs a unified movement more than ever to counteract fierce opposition in the region and worldwide.

To better fulfil our core mission, IPPF has completed a [reform](#) which has made our governance more accountable, our financial allocation system better able to ensure quality investment in the populations we serve and our safeguarding mechanisms stronger. A [new board of trustees](#) was appointed in June 2020.

Scoping New Countries

IPPF will expand its presence in the Americas and the Caribbean region by inviting one national organisation to become a member association in key countries which have been prioritised according to SRHR needs or potential to contribute best practice.

Scoping reports have been produced which include a list of 10 key informants. This consultancy is focused on carrying out these key informant interviews.

Purpose of this consultancy

The main purpose of this consultancy is to carry out ten interviews with key informants recommended by the Scoping reports undertaken in Haiti.

Terms of Reference with more details will be available to pre-selected candidates.

Interviews will be carried out remotely in French and the report will be written in English.

Reporting line

The consultant will report to the Americas and the Caribbean Transition Regional Director.

Duration: The consultancy will start as soon as possible.

Person Specification:

- Academic background in social sciences, gender, health, or related area.
- Significant experience on conducting in-depth interviews and qualitative analysis
- Significant experience on working with civil society on SRHR and/or gender equality in country.
- Excellent command of oral and written English and French with outstanding synthesis skills.
- Experience of working in NGOS in low income countries.
- Embraces diversity of all sorts.
- Supports bodily autonomy including women's right to choose an abortion is essential.
- Consultancy experience including working by products and report writing experience is required.
- To ensure objectivity, consultants not living in Haiti for the last 5 years will be preferred. Haitians living abroad for more than five years are very welcome to apply.
