Achievements to Date:

- The CSO Residential Workshop took place at the Royalton Resorts in Trelawny Jamaica from January 30, 2017 February 1, 2017

- The workshop met its objectives. Of the total participants who completed the final evaluation 61% rated it as "Excellent" while the other 36% rated it as "Very Good"
- Participants reported that they found the experience to be very useful and felt the tools provided were practical for use with their target populations
- including the use of specific GPA tools/activities. The facilitators will also provide one-on-one support for individuals and agencies who may have difficulty with any Since the workshop, technical support has been provided to the organizations to support their planning of session to incorporate the Empowerment GPA system concept or activity

- the facilitators offered support where necessary. incorporate the GPA system in their work outside of on a one-on-one basis with clients. Several participants suggested conducting interventions with their staff and Organizations who indicated that they did not usually do large group interventions with the key populations expressed some concerns about how they would
- to determine how these organizations will complete an appropriate intervention. with assistance in designing what their intervention will be around as well as working out what specific activities they will incorporate. Follow-up will continue with to provide a concrete date for their intervention. However, like all the other organizations they have commenced planning their intervention and have been provided had some challenges (delay in receiving funding, change in management structure, lack of a physical space from which to operate) which has hindered their ability Eleven (11) organizations have already set the dates for their interventions in April with the exception of SWAJ, JYAN and JN+ who have indicated that they have
- they have incorporated the GPA system. They are in the process of completing their reports on these events which they will share with the Ashe Company To date, Eve for Life and the Trelawny Parish AIDS Association have completed a residential training and community based interventions respectively in which
